MCCF WORKS THROUGH LOCAL DISASTER CASE MANAGERS WHO COLLECT NEEDED PAPERWORK, ENSURE REPAIRS ARE MADE AND WORKS WITH AND ON BEHALF OF THE SURVIVOR TO HELP THEM BACK INTO A SAFE AND HEALTHY HOME. DURING 2019, 40 HOUSEHOLDS OF 144 INDIVIDUALS HAD THEIR HOMES LEVELED, REPAIRED, ELEVATED AND REBUILT THANKS TO THIS FUND.
